- c. Summer 2011 projects what to expect
  - o No construction will be started inside the buildings
  - o Access road (2<sup>nd</sup> entrance) is planned to begin
  - Storm water in parking lots A & C, and maintenance yard (outside bldg. 2) also planned
  - o Building 2 Code Compliance Upgrades may occur
- 4. Review developments since last BISC:
  - a. Vetting scenarios of the hybrid program option for Buildings 5 and 7.
    - The campus preferred hybrid scenario that emerged in December, was somewhat over budget, leading to development of further refinements.
    - o Two other scenarios were put together and are getting closer to available funding, but still slightly over what is available.
      - Fine tuning will continue to bring final option under budget.
      - There are still significant variables that need to be determined, i.e. CRC/SLC. If it is just CRC/SLC that would be fine but it could be CRC/SLC/Library.
        - ❖ How will that be decided? Conversations need to be held soon to make a decision. A district meeting will be held on Feb. 16 at SY to go over district learning which may help in coming to the decision.
  - b. Outcomes from January 10 Bond Work Session
    - i. Swing space and critical path
      - ❖ Two sections in the Event Center will be used as swing space
      - Library 213 for classroom might be a possibility, depends on Library
      - ❖ After new addition is completed on bldg. 7 it can be used for swing space for departments currently located in bldg. 5.
      - Other swing space locations on the campus will be identified as needed during construction.

General discussion: Liked the approach of hybrid Scenario #3. Program 13000 sq. ft. 1000 sq. ft. each classroom ratio 4:1. Have we accounted for things we need? Assumptions were made. Bldg. 7 is best example of how new building areas to be built. Some classrooms will be bigger and some will be smaller than 1000 sq. ft. If we increase instruction by 23% (which is V1.6) then an assumption is that Stu. Dev. will also need to grow by 23% too. If not tied to 27 general classrooms, but grow as needed. Balance needs, over budget right now. We will need the infrastructure too, not just classrooms.
