- The old Cultural Literacy general education outcome has been changed to Social Justice.

- The committee felt it needed more time to ruminate on the outcome as proposed. Members will leave comments in the CC spreadsheet and Patty will gather those comments and forward them to the DSAC and Blake Hausman for feedback.
- It would be helpful to the committee to have Blake or another SJ DSAC representative present at next month's committee meeting.

Retreat Topic

- Remember how well the general education assessment review process worked at getting SACs to look at all their CCOGs at the same time. It allowed them to better see how uniform and consistent (or not) their CCOG language was across all their courses.
- How can SACs more easily look at the consistency of their CCOG language? What tools and processes would be needed to better facilitate this? What could the committee and the curriculum office provide?
