Policy – G307 General Education Outcomes

- Committee recommends the revision of G307 Cultural Literacy general education outcome to Social Justice.
- Over three years of DSAC work has gone into the development of the Social Justice outcome and its assessment rubrics.

- It maps to the state requirements for the AAOT's cultural literacy designation.
- The Communication Outcome has an approved description but no assessment rubric yet.
