# **SAFETY ALERT FLYER**

## Male Parked at SE Campus Engaged in Lewd Acts

Between December 6, 2021, through January 29, 2022, there have been three incidents involving a male subject parked in parking lots of the SE Campus, 2305 SE 82<sup>nd</sup> Avenue, Portland, OR 97216. On these occasions the subject was observed or suspected to be publicly masturbating in his vehicle.

This information is being provided to alert the campus community of this behavior to a) make informed decisions regarding their personal safety and b) should they observe the subject to please notify Public Safety. Following is a summary of the incidents and photographs of the subject.

Suspect Vehicle: Red Ford Ranger Pickup OR Plate 945 KYF.

**Suspect Description**: White Male, 35-40 years, , dark brown shaggy hair to his neck, and wearing a dark baseball type hat, red sweatshirt.



#### Summary of Incidents

On **Monday December 6, 2021,** at approximately **4:10pm** a Public Safety officer was walking through the **SE Campus parking lot A** when the officer observed the subject sitting in his vehicle publicly masturbating. As the officers began to approach the subject, he drove off in his vehicle southbound on SE 82<sup>nd</sup> Avenue.

On **Monday, January 24, 2022,** at approximately **12:29pm** at the **SE Campus parking lot A,** a PCC employee reported that the subject, who was wearing a black hat and feather, gestured to her that he was either asking for money or had money. The female employee contacted Public Safety. Officers suspected it was the same subject from the December 6, 2021, incident. Officers responded to the area but the subject had left prior to officers' arrival.

On **Saturday, January 29, 2022,** at approximately **1:51 pm at the SE Campus parking lot B**, a Public Safety Officer checking surveillance cameras observed the subject masturbating in his truck. The officers went to the parking lot but the subject saw the officers and left the campus.

Reports have also been written and forwarded to the Portland Police Bureau (PPB). If you have any information related to this incident or observe the subject, please call PCC Public Safety at 971 722 4902, who will also notify PPB. DPS issues Community Safety Advisories when an incident occurs on or within PCC's properties that potentially represent a threat to the campus community.

### Safety Tips & Resources

- If you see the suspect identified in this advisory, do not approach him, go to a safe place and immediately call Public Safety at 971-722-4444.
- <u>Travel in pairs or with trusted companions</u>, especially at night, or in remote areas.
- <u>If someone is intoxicated or incapacitated</u> call for a taxi or other car service, and make sure a trusted friend safely accompanies the incapacitated friend to their door.
- <u>Call Public Safety for an escort</u> from campus buildings and to your personal vehicles located on campus. The use of this service is especially encouraged after daylight hours.
- <u>Be aware of your surroundings at all times</u>. Watch for suspicious persons or activities as you are walking to your vehicle. Have your keys in hand so that you don't have to search for them when you reach your vehicle.
- <u>Be a good witness</u>: Describe exactly what you observed with as many details as possible. Give complete descriptions such as sex, race, age, height, weight, hair color, clothing, tattoos, and scars. Try to get the license plate if a vehicle is involved.
