Any students incorrectly classified as an “in-state student” will be responsible for payment and repayment of out-of-state tuition. Please allow at least 10 business days for document evaluation and residency verification.</p> <p>Please check your Visa type to see if you are eligible for in-state tuition: https://www.pcc.edu/enroll/registration/residency</p> <p><i>NOTE: To be eligible for residency reassessment, this form is due in any Admissions and Registration office NO LATER than the drop deadline of the term for which you wish to have your tuition reassessed.
