REPORT: After a formal Request for Proposals process, per Resolution #10-042 on December 3, 2009, the Board awarded the architectural services contract for the Cascade Campus 2008 bond program to THA Architecture, Inc.

An initial meeting was held with the Campus team and the and architectural firm on December 11, 2009. Authorization is needed to enter into a contract to proceed with master and solve a planning and programming/ schematic design for the Cascade Campus 2008 bond program. This work will and the include, but is not limited to: master planning; attending campus committee meetings; assistance with site location evaluation as requested; assessment of land use requirements; community outreach; programming/schematic and applied betalant design services; and other related tasks. The value of this work is estimated to be \$1,080,000, based on architectural also assembled to services equaling 10% of total project costs and schematic to MOS promocerage design representing 20% of the design effort. The expected the search and to most duration of this phase will be approximately 9-12 months, and the total contract duration six (6) years.

RECOMMENDATION: That the Board of Directors authorize THA Architecture, lnc. to provide master planning and schematic design sections make the services for the Cascade Campus 2008 bond program. The cost for these services will be approximately \$1,080,000 over the next 9-12 months. All expenditures for these services will be from bond funds.
